## Treasurer's Report End of Fiscal Year 2018 July 1, 2017 - June 30, 2018

Attached, please find the end-of-year Profit & Loss Statement and Balance Sheet.

For the year, on a cash basis, we show a loss of \$6169.00. This loss is due almost entirely to a few items:

- 1. The significant expenditures (almost \$2300) involved in sending a large contingent to the short course nationals in Indianapolis.
- 2. Overall, meet expenditures (including #1) exceeded income by over \$4000. Keep in mind some of this is timing related, as the CSU and Brogan meets span the Fiscal Year end.
- 3. We have not yet been paid by Meet Assistant for the CSU meet.
- 4. We restocked our supply of meet medals (\$1104).

All other income/expenditures are normal.
