2019 Final

When the books were closed on June 30, we recorded a net surplus of income over expenses of \$2429.57. A few notes:

- 1. We managed a "profit" on our FY 2019 meets of about \$3000.00 altogether. Brogan is our biggest "money-maker"
- 2. Workout groups: Lakewood group posted a "profit" of \$5145.00. Orange group posted a loss of \$957.00.
- 3. Please ignore the negative checking account balance on the balance sheet. That was a timing issue. Funds were transferred from Money Market on July 1 to cover last checks written in FY 2019

2020 Year-to-date

We are in fine shape to date, showing a surplus of \$1355.89. A couple of notes:

- 1. We have not yet received Avon meet income from Club Assistant
- Note payments for USMS Sanctioning fees for 2018 Open Water and Hudson, 2019 CSU and Lakewood meets. These should have been booked in FY 2019, but LEMSC never invoiced us for them. Received bill for these meets in August, after FY 2019 books were closed.

So, both of these reports show us financially healthy.
