Call to Order – Ann called the meeting to order at 5:30 pm.

- A) Preparations for the Annual Meeting:
 - i. Mark will make a list of documents to distribute at the Annual Meeting, and forward to Ann.
 - ii. The Zoom meeting will not be password protected.
 - iii. Mark will send out the SignUpGenius announcement again.
 - iv. Mark reported that, through SignUpGenius, there are 28 people signed up, and 5 maybes.
 - v. Mark reported that Zoom training has been offered to attendees.
- B) Nominations:
