Before the meeting, at 4pm, Ann introduced herself and meeting members. Attendees were broken into discussion groups until 4:35pm.

Ann announced awards (see attached program brochure) and the Lifetime Achievement Awards to Lilly Kron and Peter Van Dijk.

Call to Order – Ann called the meeting to order at 5:11 pm.

- 1. The agenda was presented. A motion to approve was made by Ann, seconded by Judi, and approved.
- 2. Minutes from last year's Annual Meeting, June 29, 2019, were approved unanimously (Boyce, seconded by Mel Smith), without changes, by the club members present. (Attached)
- 3. Minutes from the last Board Meeting, May 21, 2020, were not discussed at this meeting. Approved at July 7 Board Meeting.
- 4. Financial Report:
 - A) Keith presented a Treasurer's Summary, Balance Sheet, and Profit and Loss sheet. All are attached.
 - B) Keith stated that breaking even for the fiscal year (ending June 30, 2020) was the target. He expected the club would lose \$1000 for the year on income of about \$40,000.
 - C) The loss is due to paying coaches stipends while the club has no income.
 - D) Meet income is even despite COVID caused cancellations.
 - E) Deane Malaker asked about spending the club's surplus funds. It is clear the membership wants action. Suggestions included ALTS (Adult Learn to Swim) and the Swimming Saves Lives Foundation.
- 5. Coach Replacement for Arnie Colvin:
 - A) Many thanks to Arnie Colvin for his years of coaching for O*H*I*O Masters.

- B) Replacing Arnie will be Gabby Kariotakis. She is unable to start until the fall season, but Mark and Cameron Stewart will cover her sessions during the summer season.
- 6. Brogan Open Water Meet:
 - A) The meet has been cancelled due to the COVID pandemic.
 - B) This year's meet was to be a national meet, but Chuck indicated that we would likely be successful with a 2022 national bid.
- 7. Board Elections:
 - A) Mark explained the following slate of candidates:

- B) Ideally, there are three two-year term trustee positions each year. However, due to members leaving and changing positions, the Board needs four trustees this year. One positions will be designated a one-year trustee position.
- C) All these positions are elected by acclamation.
- D) In subsequent discussions, Nelson Abbey volunteered to take the one-year trustee position.
- 8. Thanks to Ann for Her Leadership:
 - A) Both Bruce and Andrew thanked Ann Marshfield for her leadership.
- 9. Return to Swimming at Foster Pool:
 - A) O*H*I*O Masters will return to outdoor swimming at Foster pool starting July 1. Practice times will be the same.
- 10. A Donation and How to Use Excess Funds:
 - A) Considerable discussion occurred concerning what type of donation to make.
 - B) A donation should be consistent with our mission to promote swimming.
 - C) After considerable negotiation, a motion was made: "Resolved, the Board of Trustees is instructed to convey a grant of \$100 or more to an organization that expresses our commitment to diversity and inclusion, and our mission to promote swimming."
 - D) This motion was approved 80% to 20%.
