O*H*I*O Masters Swim Club Annual Meeting June 25th 2023 Treasurer's Report for period July 1, 2022-June 20, 2023

Attached are the Club's financials for the period July 1, 2022-June 20, 2023, with a comparison to the 2021-22 financial year.

As we approach the end of the 2022-23 Fiscal Year our balance sheet remains relatively strong, with total cash of \$33,859 as of June 20th 2023. However, as you can see from the income statement there are adverse income and expense trends that need to be addressed in the coming year to ensure the continued financial strength and viability of the club.

There was a significant shortfall of income vs expenses in this past financial year, resulting in a loss for the FY to date of (\$14,529) on an accruals basis. After adjusting for working capital changes, our cash reserve fell by \$19,004. The primary cause of this was a \$11,491 shortfall in income from the Lakewood and Orange practices vs the cost of running those practices, as shown in Table 1 below. This shortfall clearly cannot continue for any length of time because at this rate it would exhaust our cash reserves within 3 years. Action will be required to reduce the level of the shortfall and your Board will be considering this at the next Board meeting.

Another large expenditure was the purchase in March of 5000 medals at a cost of \$5660 to replenish our stocks for swim meet awards. Although this infrequent cost is expensed and adds to our loss for this year, it should be seen as an investment because the medals should last a number of years.

On the positive side, our swim meets generated \$3137 of net profit, which helps defray the cost of administering the club as well as offsetting to some extent the

cost of running the Lakewood and Orange swim practices. A full analysis of the income and costs is shown in Table2 below.
