O*H*I*O Masters Swim Club Board Meeting July 21 2024 Treasurer's Report for period July 1, 2023-June 30, 2024

Attached are the Club's financials for the period July 1, 2023-June 30, 2024, with a comparison to the 2022-23 financial year.

At the end of the 2023-24 Fiscal Year our balance sheet remained relatively strong, with total cash of \$21,874 as of June 30th 2024 compared to \$29,683 at the end of June 2023. Although this represents an outflow of cash of \$7,809, it is a great improvement on the cash hemorrhaging we experienced in 2022-23, when we burned through a little over \$23,000 of our cash reserves. So the action we took in the past year to raise swimming practice fees has begun to have the desired positive effect we hoped for.

The net cost of club administration, including awards and prizes, was \$4283. This was more than offset by our net income from swim meets during the year, which was \$5386. This generated a surplus of \$1103.

As we noted last year, we lose money on running the Lakewood and Orange swim practice group, but the amount of loss has been considerably reduced thanks to the price increases we initiated in September of 2023. Table 2 below shows the practice income vs expense in 2023-24. As you can see, although we had a net loss of from running the Lakewood and Orange practices of \$6,153 this was much improved on the 2022-23 net loss of \$11,491.
