# Treasurer – Bob Boyce

Bob presented the treasurer's report. The club is in good financial situation. There was a deficit of \$19,004. The club subsidized the two workout groups this past year in the amount of \$11,491. The club also purchased 5,000 medals for \$5,026.74. \$1308 for the Avon end of simmer practices. The swim meets generated \$3137 in profit. The board plans to address the workout fee shortfall. The Orange pool increased the pool fees. Lakewood costs stayed the same. Ann Marshfield reported on the history of the club membership fee. In the past the club charged a membership fee of \$5. This was discontinued when the integrated fee went into effect at the national level. USMS does not collect club membership fees. This would have to be done by the club. There was a question of how many punch passes are outstanding. Bob reported that there is not a process to keep track of this. A member commented that the club is carrying a balance of \$33859 in the bank and that this is too much for a non-profit to carry. Encouraged the board to spend down this balance to under \$10,000-\$15.000.

Sara encouraged members to email suggestions to Bob and Sara regarding this issue. The board will address this at its next meeting.

## Brogan Open Water Race – Chuck Beatty

Chuck reported that there are 92 registered swimmers. Chuck anticipated a loss for the race. Costs have increased. Chuck asked for people to enter the race or to volunteer.
